# **Privacy Policy**

SonoClipShare ("us", "we", or "our") operates the https://www.sonoclipshare.com/ website (the "Service").

This page informs you of our policies regarding the collection, use, and disclosure of personal data when you use our Service and the choices you have associated with that data.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. ### **Information Collection And Use**

We collect several different types of information for various purposes to provide and improve our Service to you.

### **Types of Data Collected**

#### **Personal Data**

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Cookies and Usage Data

#### **Usage Data**

We may also collect information how the Service is accessed and used ("Usage Data"). This Usage Data may include information such as your computer's Internet Protocol address (e.g. IP address), browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

#### **Tracking & Cookies Data**

We use cookies and similar tracking technologies to track the activity on our Service and hold certain information.

Cookies are files with small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Tracking technologies also used are beacons, tags, and scripts to collect and track information and to improve and analyze our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, you may not be able to use some portions of our Service.

Examples of Cookies we use:

- Session Cookies. We use Session Cookies to operate our Service.
- **Preference Cookies.** We use Preference Cookies to remember your preferences and various settings.
- **Security Cookies.** We use Security Cookies for security purposes.

### **Use of Data**

SonoClipShare uses the collected data for various purposes:

- To provide and maintain the Service
- To notify you about changes to our Service
- To allow you to participate in interactive features of our Service when you choose to do so
- To provide customer care and support
- To provide analysis or valuable information so that we can improve the Service
- To monitor the usage of the Service
- To detect, prevent and address technical issues

#### **Analytics**

We may use third-party Service Providers to monitor and analyze the use of our Service.

#### Google Analytics

Google Analytics is a web analytics service offered by Google that tracks and reports website traffic. Google uses the data collected to track and monitor the use of our Service. This data is shared with other Google services. Google may use the collected data to contextualize and personalize the ads of its own advertising network.

You can opt-out of having made your activity on the Service available to Google Analytics by installing the Google Analytics opt-out browser add-on. The add-on prevents the Google Analytics JavaScript (ga.js, analytics.js, and dc.js) from sharing information with Google Analytics about visits activity.

#### **Authentication**

We use third-party Service Providers to help facilitate website authentication to improve the use of our Service.

#### Auth0

Auth0 is a web authentication service used by SonoClipShare to facilitate user authentication and maintain user login credentials. It allows our website to offer Single Sign On, one-click authentication. Auth0 also negotiates authentication tokens with google for users that login using their gmail credentials, allowing our website to access a user's gmail contacts.

#### Google API Services

Google API Services are a web services offered by Google that allow SonoClipShare to access a user's gmail contacts to facilitate sharing of ultrasound clips and archives on our website.

- When a user logs in using his or her gmail credentials, they authorize SonoClipShare to obtain a Google Contacts API token on their behalf.
- This token is a special string of characters ( a password, of sorts ) that is obtained by our website and then delivered to the user's browser.
- When combined with the Google Contacts API url for this user, the token will then be used by the browser (either Chrome, Internet Explorer, Edge, Safari, Firefox, etc) to access their gmail contacts when sharing ultrasound archives.
- The token can only be used for read access to the users gmail contacts and cannot be used to modify or delete a user's gmail contacts.
- SonoClipShare only briefly stores this token and does not directly access the user's gmail contacts.
- However, SonoClipShare will save a secure database of email addresses and names for those contacts with whom the user has selected to share an archive.
  These email addresses and names will be maintained with the same privacy policies outlined in this document.
